## Procedures for Scheduling Tour Dates

Dear Host/Sponsor:

The **Flame of Fire Summer Tour 2008**, featuring **Minister Ursula T. Wright (a.k.a. Tirshatha)** is scheduled between **June 19<sup>th</sup> and August 3<sup>rd</sup>**. The tour will include an anointed worship service that skillfully combines choreographed songs with live prophetic worship to produce a God-encounter like no other. Additional add-on options will include: (a) workshop on “Governmental Worship”, (b) prophetic preaching, and/or (c) a worship team consultation. Included herein you will find all that you need to secure and book the **Flame of Fire Summer Tour 2008**. To initiate the process of scheduling all of the arrangements, please adhere to following the steps below:

**Step 1:** As an initial step we ask that you read over the **Mission** embraced by Minister Wright. The purpose in asking you to do this is to make sure that you are aware of the mission the Lord has set before Minister Wright and the values to which she ascribes.

### Mission

**Minister Wright** uses the tool of praise and worship to compel the body of Christ to worship in a new dimension of breakthrough and power. Her ministry is multi-dimensional and reflects:

- **Worship** that transforms people, cities, and nations.
- **Intercession** that annihilates darkness and expands the gateway of God for manifested results.
- **Deliverance** that has the power to recover the destruction initiated by the enemy, transferring it into the authority and dominion of God, and abolishing every work that interferes with God’s plan and purposes.
- **Prophetic Ministry, Teaching and Impartation** that demonstrates that the power of the Word of God is a two-edged sword useful for strengthening, transforming, establishing, and equipping the nations for the manifested power of God.

### **Expenses:**

Minister Wright is doing the FOF tour – **FREE OF CHARGE**; and is instead accepting love offerings for her ministry. The only commitment from the church/sponsor would be:

- Two round-trip fares for Minister Wright and one assistant (preferably non-stop flights)
- 2 Hotel Rooms with Double Beds
- Ground transportation from airport/church/hotel
- Permission to sell product before service, during intermission and after service. Two volunteers will be needed to assist in sales.

### **Sound Equipment:**

The ministry host agrees to provide a piano or keyboard (Korg, Yamaha, Roland, or one of similar quality) and keyboard stand; cd player, speakers, and 1 cordless microphone for use by Minister Wright during ministry.

### **Recording Requirements:**

The ministry host acknowledges that (other than as set forth below) neither FLAME OF FIRE MINISTRIES nor any of their representatives have granted the ministry host any rights with regard to utilizing any form of recordings of Minister Wright's singing, teaching, preaching, worship, or other service as contracted for in this Agreement.

### **In this regard, ministry host understands:**

1. That recordings of services can be given away "free" or sold at a fixed or nominal fee to the attendees at the event.
2. That FLAME OF FIRE MINISTRIES is the sole owner of any recordings made and maintains for itself the right to approve or disapprove of any prospective uses of such recordings.
3. That within 15 days of the ministry time, the ministry host will respectfully provide FLAME OF FIRE MINISTRIES with one master quality copy of all services recorded sent to (PO Box 681777, Miami, FL 33168, Attention Minister Ursula T. Wright).
4. That requests for any other contemplated uses for such recordings are to be emailed to Tirshatha Corporation (at [booking@tirshatha.com](mailto:booking@tirshatha.com)) no less than 15 days in advance of such ministry time.
5. That any uses for such recordings other than as covered above require the written (or e-mailed) approval of Minister Wright. Verbal authorizations or any other manner will not be accepted to request permission for recordings.

### **Sale of CD's:**

Ministry host agrees to provide an area and provide (2) volunteers to oversee the sale of Minister Wright's CDs both before and after each service, unless otherwise determined that Flame of Fire Ministries will provide staff to sell cd's. Each CD will be sold at \$15.00, checks payable to Ursula T. Wright unless otherwise noted. Ministry host will not charge FLAME OF FIRE MINISTRIES or take a % of the CD sales. Ministry host agrees to make announcements at each service as to the availability and location of the CD sale.

### **Cancellation Procedure:**

Ministry host agrees to cancel at least 30 days in advance of ministry date.

### **Entire Agreement:**

This agreement constitutes the entire understanding and agreement between both parties with respect to the Flame of Fire Summer Tour 2008 Information Form. This agreement may be amended only in writing and signed by ministry host and Minister Ursula T. Wright or authorized designee.
